## STRATEGY OF THE MONTH

## Clarifying Questions

Sometimes disputants (or friends and family) don't provide all of the information we need to understand their perspective the first time. Here are some clarifying questions you can use to better understand people without making them feel judged or attacked.

- How is this different from what you expected?
- How is this experience like others you have had?
- What are some of the ways you have handled such situations before?
- Will you please give an example?
- How do you feel about what was just said?
- I wonder why that is so. Any thoughts?



Restate and reflect what you hear the person say so that you can be sure you understand them.
