STRATEGY OF THE MONTH

Rude, Mean, or Bullying?

TAP mediations are often used to cut through a pattern of bullying before it escalates to violence. Sometimes, it can be hard to identify what actions constitute bullying versus one-time behaviors that, although not part of a pattern, can still be hurtful. Here are some helpful distinctions from Signe Whitson's article "Rude Vs. Mean Vs. Bullying: <u>Defining The Differences</u>":

- Rude behavior = Inadvertently saying or doing something that hurts someone else.
- Mean behavior = Purposefully saying or doing something to hurt someone once (or maybe twice).
- Bullying = Intentionally aggressive behavior, repeated over time, that involves an imbalance of power.
